The attention of all the Municipal Commissioners of all the ULBs is invited to the references cited, wherein the Govt of India has launched the flagship program Swachh Bharat Mission with the vision of ensuring hygiene, waste management and sanitation across the nation. Keeping in view of the above Mission, the Government of India have released an amount of **Rs.17.22 Crores** for the year **2014-15** for construction of (43050) units of IHHT @ of Rs.4000 per unit and the State Government have also released the apportioned share for the above units @ of Rs.8000/- from State Finance Commission, TSP and SCSP funds.

2. In this connection vide this office references 1st to 3rd read above entire amount was released to (39) ULBs for completion of construction of IHHT as mentioned at "**ANNEXURE-A**" for the year 2014-15 i.e., GoI share of Rs.4000/- and State Govt Share of Rs.8000/-.

3. As the construction of IHHL is being taken up in full pace, the balance of Rs.4000/- as State Government Share is being released to the balance ULBs concerned against the Units mentioned at "**Annexure-B**".

4. The Municipal Commissioners of the ULBs are instructed to strictly follow the guidelines issued by this office, before making payments to the beneficiaries like certifications from the concerned Assistant Engineers etc., and "Geo Tagging" of the unit. The above amount shall be released only after completion of construction of IHHT. The beneficiary photo and place of construction of unit shall be invariably uploaded on the website before making payments. The total unit cost shall be directly transferred to the beneficiary's account through online and there shall not be any disbursement through cash. Any default in this regard will be viewed seriously.

5. The Municipal Commissioners are once again instructed to conduct thorough checks and satisfy himself before making payments and shall not give any room for misappropriation of funds or deviations to the procedures.
